## Remarks:

On July 29, 2019, the merger (the "Merger") of 300 Holdings, Inc., a wholly owned subsidiary of Fiserv, Inc. (the "Issuer"), with and into First Data Corporation ("First Data"), pursuant to the Agreement and Plan of Merger, dated as of January 16, 2019, was completed. Prior to the completion of the Merger, no securities of the Issuer were beneficially owned by the Reporting Person. This report does not include the securities of the Issuer acquired by the Reporting Person upon the completion of the Merger. The Reporting Person will separately file a Form 4 reflecting the Reporting Person's acquisition of securities of the Issuer in connection with the completion of the Merger. Mr. Nuttall, an executive of Kolhberg Kravis Roberts & Co. L.P. ("KKR"), is a member of the board of directors of the Issuer. Certain affiliates of KKR will file a separate Form 3 reporting securities of the Issuer that they may be deemed to beneficially owned by affiliates of KKR.
